**END USER LICENSE AGREEMENT (EULA)**

To use this version of the SURGIVISION® DATA LINK™ IOL Edition Software ("SURGIVISION® DATA LINK"), you must first review and agree to all of the terms of this License Agreement. Any use of the SurgiVision® Data Link confirms acceptance of these terms in their entirety and without alternation:

This SURGIVISION® DATA LINK™ License Agreement ("License") is your proof of license for the SURGIVISION® DATA LINK™ software ("the Software"). An electronic copy of this license may be found at our web site <http://IOLSurgeon.SurgiVision.net>. This License must be acknowledged and agreed to prior to first use of the Software, and remains in effect for every use of the software by any and all parties.

**1. Grant and Term of License.** SurgiVision® Consultants, Inc. ("SVC") grants you a personal, non-exclusive, non-transferable right to use the Software for one year from the date of activation. Extension of the license shall be granted based on authorization by Bausch & Lomb. Licensing is provided on a per-surgeon basis. Entering information from any surgeon other than the surgeon to whom the license is granted constitutes a license violation.

This License shall continue in effect until terminated by SVC. It shall be immediately and automatically revoked upon any failure by you or other persons using this software to comply with the limitations set forth in this License.

Revised Terms and Conditions of this License agreement shall be deemed accepted by you upon publication, whether or not you acknowledge receipt of the revised License.

**2. Physician Supervision Required:** Use of this software may only occur under the direct supervision and control of a qualified, licensed physician. Encryption is provided using a proprietary software package. The encryption software requires a text key to encrypt and decrypt the data. The data cannot be decrypted without the text key.

**13. Compliance with HIPAA and other Privacy Regulations:** You assume full responsibility for compliance with HIPAA and any other privacy requirements associated with use of the SurgiVision® Data Link™ software.
